Yard Waste Recycling Facility Permit Application

Yard Waste Recycling Facility Permits are available for East Earl Township and Brecknock Township, Lancaster County residents. Permits are valid for one calendar year (January-December) and **must** be renewed annually. You must have a valid current permit to use the Facility. Please complete all information and sign and date form.

To obtain a Yard Waste Permit bring your completed form and payment of **\$35.00** (cash, check or money order) to the Borough Office during office hours at 300 Broad Street, Terre Hill, PA (Monday-Thursday, 9 a.m.-12 p.m.; 2 pm.-4 p.m.). **OR** by mailing completed renewal application and payment to *Terre Hill Borough, PO Box 250, Terre Hill, PA 17581*. Completed renewal applications and payment may be mailed or dropped in our mail slot at the Borough Office. Once payment and application are received a permit will be issued to you either via US Mail or E-mail.



Terre Hill Borough Yard Waste Recycling Facility Rules & Regulations “Residential Use Only”



Location

The Terre Hill Yard Waste Facility is located at 426 Linden Street. The entrance to the facility is located directly across from Willow Street.

Yard Waste Facility

The Facility is open daily from 6 a.m. to 10 p.m. – Abuse of the facility may result in the facility operating during limited hours. We encourage you to follow the rules of the facility and to report any abuse of the facility by others. Please contact the Terre Hill Borough Office at (717) 445-4581 with information regarding suspected abusers. The facility is monitored by the use of video surveillance cameras. The Terre Hill Borough Public Work’s personnel will randomly inspect the loads coming in to the facility; you may be asked to show identification. Permits must be shown at designated area.

Upon entering the facility unload the yard waste onto the proper pile. All unload areas will be marked. Grass Clippings are to be separated from all other yard waste. Place all woody material, leaves, garden residue in the large bin. Place grass clippings in the bin designated for Grass Clippings ONLY. **Please unload yard waste as close to the existing pile as possible.**

Accepted Items

1. Grass clippings
2. Leaves
3. Shrubbery trimmings, flower and garden residues.
4. Woody material – such as branches, trees up to 24 inches in diameter and not over 8 feet in length.
5. Left over new building lumber, such as 2 x 4, 2 x 6, etc. Must be solid wood, **No Plywood Or Processed Wood.**
6. Live Christmas trees - (no artificial trees) All Christmas trees must be free of all lights, ornaments, tinsel and any other decorations.

All yard waste must be removed from bags, boxes, etc., bundles must be untied. All bags, boxes, rope, wire, etc. must be disposed of in the trash.

Items Not Accepted

1. Wood over 24 inches in diameter or over 8 feet in length.
2. Tree stumps.
3. Painted, pressure treated wood, railroad ties or landscaping timbers.
4. Wood with any nails, staples or any kind of foreign object applied.
5. Plywood, drywall, processed wood.
6. Potted flowers or shrubs (containers must be removed from plants and discarded in the trash!)
7. No household appliances; furniture or any other kind of trash that is not yard waste.

Anyone caught dumping anything other than the permitted yard waste will be prosecuted for dumping rubbish.

All permits are valid for one (1) calendar year (January through December). Permit must be displayed when using Yard Waste Facility.

Permits Are for Residential Use Only – No Commercial Landscapers. **Permit are for the designated property only!** You are not permitted to collect yard waste from any other property and dump it at the Yard Waste Facility.
